SCHOLARSHIP ANNOUNCEMENT

Coast Central Credit Union, with over \$718 million in assets, is one of the largest and the oldest locally-owned financial institutions on the North Coast. A major purpose of the credit union is to strengthen the community where we live and work. The Board of Directors of Coast Central believes that supporting education is an effective way to ensure the future strength of our community, as well as support the aspirations of our youth.

The Scholarship Committee of Coast Central Credit Union is interested in assisting a broad spectrum of students who intend to continue their education. A total of thirteen scholarships may be awarded to qualified applicants, based on their academic record. Serious consideration will be given to those students who have demonstrated a commitment to education, either through outstanding academic performance or through consistent improvement during their high school years, as well as financial need.

VALUE:

The value of each scholarship in the first and second years is \$750 per year. In the third and fourth years, the value is increased to \$1,250 each year for a potential total value of \$4,000. To receive the entire scholarship, students must attend Humboldt State University, College of the Redwoods, Shasta Community College, or Chico State University and maintain at least a "C" or better GPA.

QUALIFICATIONS:

1. Student must be a graduating senior from a high school located in Humboldt, Del Norte or Trinity county.
2. Students must apply and be accepted to attend College of the Redwoods, Humboldt State University, Shasta Community College, or Chico State University as a full-time student (12 units) or more for the Fall 2008 semester.
3. Applicant must have a high school grade average of "C" or better.
